

**RESOLUTION NO. 26-01**

**A RESOLUTION ESTABLISHING AND ADOPTING  
WATER RATES AND SEWER RATES, EFFECTIVE JULY 1, 2026,**

WHEREAS, § 9-1-4 (A) of the Sinclair Municipal Code grants the governing body Authority to establish monthly water rates, sewer rates and fees for water service and sewer service from time to time, by resolution; and

WHEREAS, the governing body finds that it is in the public interest to establish Water and sewer rates as set forth hereinbelow;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF SINCLAIR, WYOMING that the following monthly rates for water services should be, and they are hereby established and adopted to be effective July 1, 2026:


<b>RESIDENTIAL WATER RATES:</b>	\$9.00 Availability Fee \$2.88 per 1000 Gallons
<b>BUSINESS WATER RATES:</b>	\$11.00 Availability Fee \$3.58 per 1000 Gallons
<b>COMMERCIAL/INDUSTRIAL WATER RATES:</b>	
<b>WITHIN TOWN LIMITS:</b>	\$12.00 Availability Fee \$7.82 per 0 TO 2000 Gallons (Plus) \$5.59 per 2001 TO 150,000 Gallons \$6.21 per 150,001 TO 300,000 Gallons \$6.88 per 300,001 TO 450,000 Gallons \$7.49 per 450,001 to 600,000 Gallons \$8.17 per 600,001 TO 750,000 Gallons \$14.37 per 750,001 and Greater Gallons

<b>DEPOSIT FOR SERVICE</b>	\$50.00
<b>SEWER RATES</b>	\$13.00 per Month
<b>LANDFILL RATES</b>	\$12.36 per Month

The Town Clerk may provide copies of this resolution to persons requesting the same by mail upon receipt of payment, in advance, of an amount sufficient to pay the costs of postage.




